City of Long Prairie Council Meeting 7:00 P.M., Monday, July 15, 2013

The Long Prairie City Council met in regular session at City Hall, 7:00 p.m., Monday, July 15, 2013. Mayor Don Rasmussen called the meeting to order with the following present: Council members Tony Towle, Lilah Gripne, Bob Klick, Art Rowan, and City Administrator/Clerk David Venekamp.

Council member Gripne motioned Towle seconded to approve the council minutes of July 1, 2013 and the July invoices. Motion unanimously carried.

City Auditor Dennis Bacon reviewed the 2012 audit report. Dennis stated that nearly every fund increased in cash and assets. Those funds that did not increase were offset by the city paying off bonds which, had they not, would have increased their net income. Dennis stated the city is in good financial condition.

Council member Rowan motioned Gripne seconded to approve the 2012 audit report as presented. Motion unanimously carried.

The council discussed the possible use of the Industrial Park for parking during Hillig's auction sales. Individuals attending the sales have parked in adjoining businesses' parking lots and in the road right-of-ways making it dangerous for individuals attending the sale. Mary Hillig had asked if it would be possible for individuals to park in the Industrial Park during the day of the sale. Hillig's would provide transportation service from the industrial lots to the sale.

Council member Gripne motioned Towle seconded to allow Marv Hillig to use lots 1 & 2 of Block 2 in the Industrial Park for parking during his sales providing Marv provides the city with a certificate of insurance naming the city as an additional insured; and the lots must be left in the same condition as prior to their use. Motion unanimously carried.

Council member Rowan motioned Gripne seconded to approve a temporary on-sale liquor license to the Todd County Ag Society for August 14th through the 18th at the fairgrounds. Motion unanimously carried.

Council member Gripne motioned Rowan seconded to approve the following resolution of investment acknowledging the investment of city funds and designating individuals who may do so on behalf of the city:
